- A103: New elevator was revised to an electric version. The dimensions of the CMU shaft have been revised, but north wall and east wall are in same location. Elevator controls are in the door buck on the Main Level and the lower level Machine Room has been eliminated in its entirety.
- A104: New elevator CMU walls have been revised.
- A105: 1/A105: New CMU elevator shaft walls have been revised, per A103 above 3/A105: Machine Room 201 has been eliminated, including door 201 Door 101 to elevator shaft has been eliminated, w/decorative reveals extended. Existing Mechanical Room door has been shifted west to accommodate new
 - elevator shaft size and maintain ADA side jamb clearances.
